There will be a public meeting at Club Eden on March 5 at 7pm to discuss safety concerns on 428th avenue between 120th and 122nd street.

Dinger informed the Board that AmeriPride will require Service Agreements with all their Clients in the near future. When she receives an Agreement from them, she will present it to be reviewed and action taken at that time.
