Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss highway department business. Hofland reported that the highway department has been working on blading, hauling gravel, and hope to replace culverts by Veblen this week. Hofland hopes for begin patching on County road 12A next Tuesday.

Donna Small verbally requested that an approach be installed near her property on the Roy Lake road. Hofland will check the area, have her fill out a petition and have an appropriate approach installed.

Symens reported that he has not heard anything from NECOG about possible grants for the Eden Township road or for County Road 4AW.

TransCanada Pipeline has offered to pay a settlement for damage done to county roads due to the oil spill clean-up. Hofland will confirm the amount and present it for approval at the next commission meeting.

Dinger reported on the SDACHS Office Personnel workshop she attended in Pierre, furnished the Auditor's office the Notice and Specifications Forms for the Bid Letting on April 7th at 9:30 am for the 2019 or newer Twin Screw Tandem, Diesel Dump Truck, Cab and Chassis, and presented for authorization and approval the following:

Knebel moved, Schuller seconded to authorize the chair to sign the Notice to Proceed for Bates Construction Company on the bridge replacement 46-030-114 (middle bridge) on county road 11AC. All members voted aye.

Luttrell moved Symens seconded to authorize the chair to sign the easement for buried lines with Lake Region Electric Association for the County Highway Department Britton Shop. All members voted aye. Luttrell moved, Schuller seconded to adopt the County Highway Superintendent Records Retention and Destruction Schedule manual from the SD Bureau of Administration-Records management program. All members voted aye.

NEW HIRE:

Hofland informed the board that Kevin Kraft has been hired as a full time highway maintenance worker effective May 28, 2018 at a rate of \$13.50 per hour.

GROW SD:

Rebecca Honl, Grow SD met with the board to thank them for their annual contribution to the program and to ask for continued support in 2019. Honl presented a report of the Grow SD's 2017 investment in Marshall County showing that over \$3.5 million was invested.

LIBRARY:

Janelle Swanson, Virginia Anderson and Barb Kuske, Britton City Library representatives met with the board to request support from Marshall County in order for the board to be able to expand outside of Britton City. Knebel moved, Luttrell seconded to contribute \$1,000 to the Britton Library annually. All members voted aye.
