ZONING:

Shannon Lee, Zoning Director met with the board to discuss Zoning business. Robert Foltz is requesting a 4 foot variance to the 7 foot property line setback to build a garage on his property. Medhaug moved, Luttrell seconded to approve the variance as requested. All members voted aye.

Chad Hardy is requesting a 12 foot variance from the 50 foot high water mark setback to build two decks on his property. Knebel moved, Schuller seconded to approve the variance as requested. All members voted aye.

Luttrell moved, Symens seconded to approve the following plat: Plat of Lot 9A of Lake DuMarce Fourth Subdivision in Government Lot 5 in Section 24-T127N-R54W of the 5th P.M., Marshall County, South Dakota. All members voted aye.

HIGHWAY:

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway business. Hofland informed the board that the Highway Department has been working on hauling gravel on 11AS, 11G, 7AC, and 4AE, blading, and will be working on a haul road this week. The highway department mower at the Britton shop broke down. Hofland will look for a used mower to purchase to replace the broken one. Hofland will be discussing the haul road agreement with Mahrer Construction concerning 04AE. Dinger discussed the chip sealing for the Roy Lake and Sica Hollow roads. The SD Game, Fish and Parks is willing to pay 75% of the cost with Marshall County paying the other 25%. Hofland will look into whether these roads need to be chip sealed right now and will discuss this with the representative from the Game, Fish and Parks. Luttrell moved, Symens seconded to authorize the chair to sign the

financing documentation for the purchase of the new John Deere blade. All members voted aye.

EXECUTIVE SESSION:

Schuller moved, Knebel seconded to enter into executive session at 10:04 am to discuss personnel matters. All members voted aye. The chairman called the board out of executive session at 10:49 am.

BID OPENING:

The following bids were opened and publicly read for the sale of various surplus items: Douglas Medhaug Metal Cart #1 \$27.00, Metal Cart #2 \$28.00; Shannon Lee Metal Cart #1 \$40; Carmin Wade Metal Cart #1 \$101.76, Metal Cart #2 \$101.76; Kalissa Stelzer #3 Small Wooden Desk \$20. Symens moved, Knebel seconded to accept the bid for both Metal Carts from Carmin Wade. All members voted aye. Knebel moved, Symens seconded to accept the bid for the Small Wooden Desk from Kalissa Stelzer. All members voted aye.

LAW CONTRACTS:

Betty Hilleson, Cary Anderson, Kristin Hofland, Ann Nordquist, Orrie Jesz, Brian Beck, Austin Sasker, Clyde Fredrickson, Dale Elsen and Dana Frohling met with the board to discuss Law Contracts with the Cities. The Veblen population was discussed as there were construction crews in Veblen building on to the Dairy when the 2010 census was done, so population numbers are skewed. Symens moved, Knebel seconded to use the 1990 census population of 321 people for Veblen and the 2010 census numbers for all other towns until the next census numbers are released. All other aspects of the contract will remain the same. All members voted aye.

EXECUTIVE SESSION:

Luttrell moved, Symens seconded to enter into executive session at 11:37 am to discuss personnel matters. All members voted aye. The chairman called the board out of executive session at 11:46 am.

RESIGNATION:

Knebel moved, Luttrell seconded to accept the resignation of Lori Greenmyer from the part-time cleaning position at the Courthouse effective July 31. All members voted aye.

COURTHOUSE:

Dean Marske, HKG Architects met with the board to discuss the courthouse renovation/law enforcement center project. Symens moved, Knebel seconded to hire HKG Architects to do Feasibility and Master Planning Study for \$26,500. 50% of this fee will be credited back to the County if Marshall County and HKG Architects moves forward with the project.

CERTIFICATION:

The board would like to congratulate Bryan Schreur on fulfilling the basic training requirements for Certification as a Law Enforcement Officer in the State of South Dakota

as established by the Law Enforcement Officers Standards and Training Commission in accordance with Chapter 23-3 of the South Dakota Compiled Laws.

Per certification, Symens moved, Knebel seconded to give Schreur a \$0.50 pay raise from 19.35 to 19.85 effective June 10. All members voted aye.

TAX PAYMENTS:

Ruby Hagen, Treasurer met with the board to present a payment agreement for delinquent taxes. Symens moved, Luttrell seconded to accept payments of \$150/month from Don and Shelly Cease. All members voted aye.

HB 1195:

Ruby Hagen, Treasurer met with the board regarding HB 1195. Symens moved, Knebel seconded to keep the Marshall County Wheel tax when refunding license fees pursuant to HB 1195. All members voted aye.

RESIGNATION:

Schuller moved, Luttrell seconded to accept the resignation of Jeri Smith from the parttime Deputy Treasurer position effective August 31. All members voted aye.

RECESS:

The board recessed out of regular session at 12:25 pm for lunch and re-convened at 1:05 pm.

NEW HIRE:

Luttrell moved, Schuller seconded to hire Erin Collins-Miles as Zoning Director at a rate of \$18,200/year effective July 16. This salary is based on approximately 25 hours/week, however the board requested that time be tracked to get a better estimation of time spent in this position. All members voted aye.

TRAVEL:

Symens moved, Knebel seconded to authorize the following travel expenses: Shannon Lee and Erin Collins-Miles to Aberdeen for a FEMA training meeting July 17; Lynda Luttrell, Matt Schuller, Megan Biel, Kalissa Stelzer, Shannon Lee and Erin Collins-Miles to Aberdeen for a Lake Region District Meeting July 18; All Commissioners to Britton for an LEPC meeting July 18. All members voted aye.
