# **ZONING:**

Shannon Lee, Zoning Director and Erin Collins-Miles, Zoning Director-in-training met with the board to discuss Zoning business. Medhaug moved, Knebel seconded to approve building permits for the following applicants: Kevin & Bonnie Lein, Paul Thayer & Cyndy Grandpre, Penhros Farms, Jim Freudenthal, Sonny Nickeson. All members voted aye.

The board discussed a road along a lake that does not follow the plat. An individual wants to replace a building along this road. The board advised Lee to ask the applicant to apply for a variance to be fair to other landowners who could have this same situation.

#### **HIGHWAY:**

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway department business. Hofland reported that the highway department has been working on hauling gravel, replacing culverts and he hopes to start patching roads soon. The Chip seal project will also be starting in the next couple of weeks.

The board set the public meeting date for the Highway Department's 5-year plan for September 18 at 9:30 am in the Commission Meeting room in the courthouse. The board asked that Hofland apply for a Bridge Improvement Grant for bridge 46-141-000 on the ND line and 46-130-109 which is in a township road south east of Britton.

Knebel moved, Schuller seconded to approve an approach permit for Dale Freeman. All members voted aye.

Hofland informed the board that the Game, Fish and Parks estimates that the county's share of the Sica Hollow Road Chip Seal will be \$10,870.92. The GF&P will be sending out an agreement to be signed by the board for the Roy Lake road chip seal project. Dinger informed the board that BDM is doing some upgrading work and is working on Right-of-way easements for a future meeting. The board discussed various roads that should be corrected at the State level as far as County ownership in order to get all documentation completed so that DOT records are current for the roads Marshall County maintains on the County's highway system. A copy of the roads needing correction has been sent to the State's Attorney's office for review. Dinger will check with a representative at the State regarding when the Roy Lake road was designated as a secondary road for Marshall County and ask for any documentation they have.

#### **EXECUTIVE SESSION:**

Schuller moved, Knebel seconded to enter into executive session at 10:25 am to discuss personnel issues. All members voted aye. The chairman called the board out of executive session at 11:24 am.

## **SHERIFF:**

Sheriff Dale Elsen met with the board to discuss a contract drafted by Deputy State's Attorney Victor Rapkoch that would require a deputy that is sent to Law Enforcement training by Marshall County to remain a Marshall County deputy for 2 years. Sheriff Elsen had some minor changes to make to the contract before it is finalized. A final contract will be presented to the board for approval.

Elsen also discussed a mobile home that he recently served a distress warrant on. The board asked that Elsen contact the owner to see if they would be willing to sign the mobile home over to the county without having to go through the tax deed procedure.

#### **WELFARE:**

Luttrell moved, Schuller seconded to approve a welfare claim of \$421.68 to USDA-Rural Development. All members voted aye.

#### ALCOHOLIC BEVERAGE LICENSE:

Symens moved, Schuller seconded to approve Hunting Preserve Liquor License renewal for Prairie Sky Game Ranch & Guest Lodge. All members voted aye.

The board discussed a liquor license that is available in Marshall County. Auditor Biel will check with Legislative Audit on Auctioning the license and report back to the board.
