Unapproved MARSHALL COUNTY COMMISSION MEETING Britton, South Dakota

The Board of County Commissioners met in emergency session at 3:30 p.m. on December 14, 2018 at the Marshall County Courthouse. Members present were Medhaug, Symens, Schuller, and Luttrell. Commissioner Knebel arrived during the Public Comment portion of the meeting.

AGENDA:

Luttrell moved, Symens seconded to approve the agenda for December 14, 2018 with the addition of a time for Public Comment. All members present voted aye.

PUBLIC COMMENT:

Doug Card was present representing the Britton Journal.

Commissioner Medhaug asked for anyone wishing to make public comment to state their name and make brief comment. Holland introduced himself and spoke in support of Elsen. Holland stated that Elsen treats people not as numbers, but as people and is respected in the community. Lloyd introduced herself and stated that Elsen has helped in situations when other deputies didn't and that people make mistakes, but Elsen has made a difference in people's lives. Eikamp asked the board to explain what happened. Chairman Medhaug explained that charges against Elsen were brought to the South Dakota Law Enforcement Officers Standards and Training Commission after complaints were investigated by the Division of Criminal Investigation. The Law Enforcement Officers Standards and Training Commission held a hearing on December 13 in which it voted to remove Elsen's certification. Individuals asked what they can do to support Elsen. The board advised everyone present that Elsen's certification is out of Marshall County Commission's hands and an appeal is up to Elsen and his attorney.
