HIGHWAY:

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway business. Hofland reported that the Highway Department has been working on plowing snow and the snowblowers are ready in the event of a large snowfall. The BIG grants have been submitted for 46-130-109 (.9S2E of Britton) and 46-141-100 (10N3.1E of Britton). Hofland does not plan to attend the NACE conference this year as the agenda appears to be more geared towards cities.

Dinger reported that State engineers are still trying to come up with a way to get lighting to the intersection of the county highway and the train tracks between the City of Britton and the Industrial Park North of Britton on county road 9AN. The County will be notified once a plan has been figured out and then the project will have to be put out to bids once an agreement has been signed between the State and the County as this is a Grant project. The State still hopes to complete this in 2019.

Dinger reported that Ulteig Engineering asked the State to be allowed to extend the time they needed to get the maps to the State to January 19, 2019, since due to the unpredictable fall weather some township farmers were busy with harvest and were unable to get in and finish their Township maps. Under the terms of the agreement with the SD DOT, the overall completion date is changed from June 5, 2019 to June 5, 2020. This allows a full year after the letting for any questions and funding available for these questions.

FUEL QUOTES:

Sandy Dinger received the following quotes for #1 diesel fuel for the Langford, Eden and Veblen shops: DaMar Elevator: Langford-2.32, Eden-2.37, Veblen-2.45; Eden Oil-2.46 all locations; Holland Bros Oil-2.45 all locations. Diesel Fuel was delivered to the Eden and Langford shops

by DaMar Elevator and to the Veblen shop by Holland Bros Oil. As DaMar and Holland's had the same price for the Veblen shop, proximity to Veblen was the deciding factor in who delivered fuel there.

VEBLEN PROPERTIES:

The board discussed two properties in Veblen owned by Marshall County. Schuller moved, Luttrell seconded to hire EE Rein Construction to tear the buildings on the properties down and dispose of them. All members voted aye.

ALCOHOLIC BEVERAGE:

Schuller moved, Jones seconded to approve a retail (on-sale) liquor license renewal for China Town. All members voted aye.

EXECUTIVE SESSION:

Schuller moved, Luttrell seconded to enter into executive session to discuss personnel matters at 1:55 pm. All members voted aye. The Chairman called the board out of executive session at 3:41 pm.

CLOTHING ALLOWANCE:

Jones moved, Schuller seconded to raise the clothing allowance for dispatchers to \$200/year. All members voted aye.

EMERGENCY MANAGEMENT:

Todd Landmark, Emergency Manager met with the board to present the Emergency Management quarterly report. Knebel moved, Luttrell seconded to authorize the chair to sign the report as presented. All members voted aye.

Landmark discussed the Alert Sense system that would allow the County to send out notifications to individual's phones. The board asked Landmark to look into this further.

COMMUNITY BUILDING:

Dave Severson, Maxwell electric met with the board to present a plan for replacing the furnaces in the Community Building. Severson's plan would replace one furnace every year for 4 years. The board asked that Severson look further into the system to see if fewer furnaces could be used and report back to the board.

COURTHOUSE PROJECT:

Tobin Morris, Dougherty & Company, LLC met with the board to introduce himself and the company he works for. Dougherty & Company would provide assistance with the financial planning, bond issuance, election, publication, etc. portion of building a new Law Enforcement Center/Courthouse.
