**PUBLIC COMMENT:**

Brian Maxwell, Maxwell Electric was present to make public comment regarding the generator at the Community Building. Maxwell informed the board that the generator did not kick on like it should have when the power went out last Friday, so the equipment that is backed up by the generator did not have power. When they checked the generator, it was discovered that a breaker had tripped. Maxwell Electric will look at the generator

and the equipment that is backed up by the generator to determine what caused the breaker to trip.

**WELFARE:**

Linda Haaland, Welfare Director met with the board to present a welfare claim. Schuller moved, Knebel seconded to approve a claim to Wright Funeral Home for \$2,000. All members voted aye.

**TRAVEL:**

Schuller moved, Jones seconded to authorize the following travel expenses: Linda Haaland to Sioux Falls April 8 for Cyber Security Training; Jennifer Ringkob to Pierre April 8 & 9 for a Professional Development Conference for Advisors; Dave Daberkow to Aberdeen March 28 for a Regional Council on Aging meeting. All members voted aye.

**COURTHOUSE:**

The board discussed the Courthouse heating system. Luttrell informed the board that the pump that had been repaired within the last year quit working on Thursday and the Courthouse was without heat. Johnson Controls was not going to be able to fix this until Monday due to weather, so Luttrell asked CDJ Electric to look at it. CDJ repaired it as best they could, but both pumps need to be repaired or replaced. CDJ turned in a quote to repair or replace both pumps. The board asked that Auditor Biel check into whether there was a warranty on the pump with Johnson Controls and report back to the board.

**HIGHWAY:**

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway Department business. Hofland reported that the Highway department has been moving snow and clearing roads as best they can, but with the warmer temperatures this will be more difficult as they do not want to take the heavy equipment on soft roads and ruin the road. The board set April 23 as the bid letting date for the chip seal project on County road 05A and Roy Lake road. Hofland informed the board that Angelo Aldentaler had given his verbal resignation effective immediately. The Highway department is advertising for a part time employee for the Eden shop. Schuller moved, Jones seconded to request that the SD DOT hire Clark Engineering to perform the Marshall County bridge inspections. All members voted aye. The Highway department would like to express their appreciation to the local fuel distributors for the weekly calls for quotes and fuel deliveries through this difficult winter.

Knebel moved, Schuller seconded to accept all bids for magnesium chloride, equipment for bridge construction and repair, equipment for road construction and repair, bituminous mix, and gravel. The highway superintendent has the discretion to hire any of the approved bidders taking into consideration location, material, need and availability. All members voted aye.

Knebel moved, Schuller seconded to use the bid from Beadle County for the year's supply of Metal Pipe and Bridge material. True North Steel (Formerly Huron Culvert & Tank) received the culvert bid as being the lowest bidder and in the best interest of the county; together with the bid from Forterra for pre-cast and bridge materials. Minneapolis has it on a day to day basis at 3.09 plus freight. She was able to locate some in Mandan, ND and ordered a split transport with Eden Oil with the County getting 5,000 gallons.

#### **SALARIES:**

Kalissa Stelzer, Ruby Hagen, Shannon Lee, and Dustin Hofland were present for discussion of Marshall County employee wages. Hofland expressed a need to raise pay in order to be more in line with other comparable counties. Auditor Biel presented the board with wage projections for various raises.

#### **EXECUTIVE SESSION:**

Luttrell moved, Schuller seconded to enter into executive session to discuss personnel issues at 11:25. All members voted aye. The Chairman called the board out of executive session at 11:58.

#### **EMERGENCY MANAGEMENT:**

Todd Landmark, Emergency Manager and Randy Maddox, Regional Coordinator, SDEOM met with the board to discuss the State and Local Agreement. Landmark informed the board that the paperwork and reporting requirements are the same statewide no matter if the Emergency Manager works full-time, 50% time or 25% time and have become very burdensome. The quarterly report that is required by the state now takes much longer to complete. Landmark is a 25% Emergency Manager, budgeted for about 10 hours of work/week. This additional paperwork cannot be completed in that amount of time without taking away from the performance of the other duties of the Emergency Manager. If Marshall County left the SLA, they would still receive the same services from the state, they would only be giving up the share of Emergency Management wages that is paid by the State, which is decreasing. Luttrell moved, Knebel seconded to leave the State and Local Agreement. Landmark will still be required to complete his duties as Emergency Manager, but he will not have to submit quarterly reports to the State. All members voted aye.

Landmark also gave the board an update on FEMA requirements for Townships and reported that Sandbags are available at the county highway shop.



**REGISTER OF DEEDS:**

Kalissa Stelzer, Register of Deeds and Dana Frohling, State's Attorney met with the board to discuss a property that was missing a deed. After researching the property, it appears that the County took the property on tax deed and then sold the property, but a deed was never filed to show the sale. Frohling drafted a deed to correct this and it has been filed in the Register of Deeds office.

Stelzer also asked the board to clarify a policy on the recoding fee of properties sold by Marshall County. In the past, Marshall County has not collected a recording fee for these properties, but there is nothing in codified law or in policy stating this. Other counties do collect the recoding fee from the purchasers. Schuller moved, Jones seconded to charge the recording fee to anyone who purchases property from Marshall County and to collect the fee at the time of payment for the property. All members voted aye.

**RECESS:**

The board took a one hour recess for lunch.
