ZONING:

HIGHWAY:

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway Department business. Hofland reported that he had been contacted by an individual requesting permission from the Highway department to clean out the ditch on the North side of County Highway 2 between 426 and 427th Ave. HOfland stated that the area that he is requesting to clean out is outside of the County right-of-way and is located in North Dakota. The board stated that permission is not required from the board if the location is in North Dakota and is out of the County right-of-way.
