## **PUBLIC COMMENT:**

George Flannery, Britton City met with the board to inform them that as part of the city's plan to prevent emerald ash borer infestation, the City will be removing ash trees over the course of the next 5-10 years. Flannery had counted 861 trees that need to be removed so far, but believes that number will be closer to 1,000 when the project is complete. Flannery informed the board that because the trees in the Courthouse lot are easily accessible, they will likely be removed soon. Flannery hopes to have a public information meeting to inform the public more about the emerald ash borer and the importance of removing the trees before infestation.

#### **ZONING:**

Erin Collins-Miles met with the board to discuss Zoning business. Kirby Stenvold was present for a hearing to discuss a complaint about livestock animals being kept on his property that is currently zoned commercial. Stenvold will apply to re-zone his property and have variance to lot size to zone the property as ag fringe.

## **TRAVEL:**

Schuller moved, Luttrell seconded to authorize the following travel expenses: Todd Landmark, Erin Collins-Miles, Sandy Dinger, Matt Schuller and Lynda Luttrell to Britton for Hazardous Mitigation Plan meetings January 9, 16, 23 & 30; all Commissioners to Britton for an LEPC meeting January 15. ## **HIGHWAY:**

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway business. Hofland is waiting on the final cost comparison for a used tractor with 3300 hours that can be leased for two years or a different used smaller tractor with 250 hours. The tractor will be used for snow blowing and mowing. The previous quote Hofland received only included 2019 pricing and now needs to be updated to 2020 pricing. Hofland will report back to the board.

## WEBER BODY SHOP:

Andy Weber with Weber Body Shop met with the board to discuss towing bills. Sheriff Dale Elsen was present for the discussion. Weber Body Shop has been towing vehicles since 1991 and has never set up an agreement with the county to define payment terms. The law governs towing if a vehicle is towed and then held as evidence by the county, the county is responsible for paying the bill and adding it to court costs. However, if it is not held for evidence and the tow bill is not paid by the individual, the towing company can take the vehicle and put the title in their name. The board asked Andy to meet with the States Attorney to create a proposal for payment terms.
