Erin Collins-Miles, Planning & Zoning Director met with the Board to discuss Zoning business.

Minutes

Luttrell motioned; Jones seconded to approve the minutes from July 28, 2020. All members present voted aye.

Variances:

Cynthia Bremmon has requested a variance to place a cabin on the property described as Lot 27 in the Plat of South Clear Lake Addition, Marshall County, South Dakota A Subdivision of Sattler Outlot 1 & Sattler Outlot 2 in Government Lots 2, 3 & 4, Section 24, T126N, R54W. The petitioner is asking to place the building 5ft from the property line on the East side instead of the 7ft requirement, per the Marshall County Zoning Ordinance.

Matt Kraft, adjoining land owner met with the board to object to the variance application. Medhaug motioned; Jones seconded to deny the requested 2' variance to the East property line setback to place a cabin; which will ensure that the cabin meets the 7' property line setback, per the Marshall County Zoning Ordinance. All members present voted aye.

Kari Nielsen has requested a variance to build a house and a deck on the property described as Lot 43 in Roy Lake Northside Addition in the SE1/4 of Section 21 & the SW1/4 of Section 22, T126N, R55W. The petitioner is asking to build the new structures 32ft from the normal high-water mark instead of the 50ft requirement, per the Marshall County Zoning Ordinance.

Jones motioned; Luttrell seconded to approve the requested 18' variance to the normal high-water mark setback to build a house and a deck; allowing it to be built 32' from the normal high-water mark setback instead of the 50' requirement, per the Marshall County Zoning Ordinance. All members present voted aye.
