### Minutes:

#### Drainage:

Penrhos Farms, Inc. is requesting a drainage permit for construction of a drain on the property described as the SW1/4 of Section 18, T126N, R57W. The water will flow Northwest into a natural drainage ditch on the East side of 424th Ave; for the purpose of draining water away from crop land. Construction will start on or before Oct 1, 2020 and will be completed on or before October 15, 2025.
