The chairman called the meeting to order and the Pledge of Allegiance was recited by everyone in attendance. Erin Collins-Miles, Planning & Zoning Director met with the Board to discuss Zoning and Drainage business.

Minutes:

Schuller motioned; Jones seconded to approve the minutes from November 5, 2020. All members voted aye. Roll call vote: Medhaug-aye, Schuller-aye, Knebel-aye, Luttrell-aye, Jones-aye. Motion carried.

Drainage:

Bessler Farms Inc. has requested a Drainage permit to start construction of multiple drains on the property described as E1/2SW1/4 and SE1/4 Exc. Lots 1 & 2 of Bessler Addition & Bessler 2nd Addition Section 30, T129N, R53W. The water will flow North through one of several steel culverts (see plans) located on the same properties and into a natural drain located on the same property for the purpose of draining water away from crop land. Construction will start on or before October 1st, 2020 and is to be completed on or before November 10th, 2025. Jones motioned; Luttrell seconded to approve an application to drain on the property described as the E1/2SW1/4 and SE1/4 Exc. Lots 1 & 2 of Bessler Addition & Bessler 2nd Addition Section 30, T129N, R53W. Conditions to this permit are as follows; to make the construction completion date as seen on permit application; November 10, 2025. Applicant must reapply after said date. Roll call vote: Medhaug-aye, Schuller-aye, Knebel-aye, Luttrell-aye, Jones-aye. Motion carried.

Plats:

Schuller motioned; Knebel seconded to require applicants to have all approval signatures, with the exception of the signatures of the Chairman of the Marshall County Plan Commission and the County Auditor, on all plats prior to submitting them to the Zoning office for Commissioner approval. The signatures which are considered exceptions to this ruling are acquired during the scheduled commissioners hearing upon which the Plat is approved/denied. All members voted aye. Roll call vote: Medhaug-aye, Schuller-aye, Knebel-aye, Luttrell-aye, Jones-aye. Motion carried.
