Medhaug moved, Jones seconded to accept all bids for magnesium chloride, equipment for road construction and repair, bituminous mix, and gravel. The highway superintendent has the discretion to hire any of the approved bidders taking into consideration location, material, need and availability. All members voted aye.

Metal Pipe (culverts) and Bridge Materials:

Medhaug moved, Jones seconded to use the bid from Beadle County for the year's supply of Metal Pipe and Bridge material. True North Steel (Formerly Huron Culvert & Tank) received the culvert bid as being the lowest bidder and in the best interest of the county; together with the bid from Forterra for pre-cast and bridge materials. **RESOLUTION:**

Luttrell moved, Jones seconded to pass the following resolution:

WHEREAS, the Marshall County Highway Superintendent will be placing restrictions on County Roads during the spring break-up, starting approximately MARCH 2, 2021, or sooner if conditions warrant, and DO NOW THEREFORE request that the South Dakota Highway Patrol assist in enforcing the road weight restrictions on **all posted paved** County roads. Spring conditions may deem it necessary for putting road weight restrictions on some of the County gravel roads as well.

**WELFARE:**

Linda Haaland, Welfare Director met with the board to give an update on the 211 program in Marshall County. In 2020, 213 calls were made to 211. These calls resulted in 724 needs being identified and 276 questions on mental health and addictions being answered.

Haaland also presented a welfare claim, but will need to gather more information before a decision can be made.

**TRAVEL:**

Luttrell moved, Knebel seconded to approve the following travel expenses: Shannon Lee to Watertown to prepare assessment notices for mailing February 26; Damien Bahr to Deadwood for a statewide sex offender class April 19-20. All members voted aye.

**PAY RAISE:**

Per obtaining law enforcement officer certification, Medhaug moved, Jones seconded to authorize a pay raise for Sheriff's Deputy Scott Lindner from \$20.00 to \$21.33/hour effective February 14 and for Sheriff's Deputy Justin Yablonski from \$20.00 to \$21.33/hour effective February 28. All members voted aye.

**TAX PAYMENT AGREEMENT:**

The board discussed a tax payment agreement submitted by Armano Mahe Contreras for the property owned by Miriam Romero that is at risk of being taken on tax deed. Mahe agrees to pay the taxes due in two payments: 1<sup>st</sup> payment \$900, 2<sup>nd</sup> payment \$467.66. The board accepted this agreement.

**EXECUTIVE SESSION:**

Knebel moved, Jones seconded to enter into executive session at 11:03 to discuss personnel issues. All members voted aye. The Chairman called the board out of executive session at 12:27 pm. No action was taken.
