Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board via Zoom to discuss Highway Department business. Dinger reported that spring load limits went into effect March 15. February Highway budget reports were distributed.

Jones discussed a meeting he had with the members of the Upper Crow Creek board. They have requested that the County dig down on the north side of the county road 4AW to determine the size of the culvert and to make sure that it is the correct size for this area.

Jones moved, Schuller seconded to accept all bids for magnesium chloride, equipment for road construction and repair, bituminous mix, and gravel. Metal Pipe (culverts) and Bridge Materials:

True North Steel (Formerly Huron Culvert & Tank) received the culvert bid as being the lowest bidder and in the best interest of the county; together with the bid from Forterra for pre-cast and bridge materials.
