HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board and Sandy Dinger, Highway Secretary met via Zoom to discuss Highway department business. David Geyer representing David Jones met with the board. Lee Schneider was also present. Jones is requesting that the County replace the two 36-inch culverts under the county road 12A at section 15 of Lowell Township be replaced with 42-inch culverts due to the flooding in the area that occurred in 2005. Jones wishes to prevent the road from blocking water flow in the future should a large water event occur again. The board stated that without a hydrology study on the area, it is unknown if the 42-inch culverts are appropriate or not. Hydrology studies can cost \$10,000-30,000. The board will discuss with the State's Attorney and Geyer will discuss with his client whether an agreement can be made about a hydrology study and the results of the study. This will be discussed more at the May 10 Commissioner meeting.

No bids were received for the 2011 International Tandem Truck.

SHERIFF:

Sheriff Swanson met with the board to inform them of a grant he has received for Sheriff's departments offering 4 free tires for a department vehicle.

Schuller moved, Jones seconded to authorize the chair to sign an employment agreement between Marshall County and Caden Bjordahl. All members voted aye.

NEW HIRE:

Caden Bjordahl was hired as deputy sheriff at a rate of \$20.00/hour effective March 28, 2022.

TRAVEL:

Schuller moved, Luttrell seconded to authorize the following travel expenses: Jennifer Ringkob to Watertown for a Regional YPA Planning meeting March 30 and for a Regional Youth Leadership Summit April 30, and to Yankton for an Annual SDAE4-HP Professional Association Conference May 10-12; Larissa Heitmann to Aberdeen April 14 for training on

online systems for 4H; Megan Biel to Webster for an Ambulance meeting March 29. All members voted aye.

The board discussed a revised proposal from ISG for pre-referendum planning and communication services for the courthouse project. The revised proposal removed the 3D image and reduced the cost to \$17,500. The board discussed the possibility of purchasing a building in Britton and remodeling it to house the Sheriff's and Dispatch departments. The board requested that Auditor Biel discuss this with ISG to determine the feasibility and cost of this.
