## DRAINAGE ORDINANCE FIRST READING:

The ordinance can be viewed in its entirety on the County website or in the Zoning office during regular business hours. All members present voted aye. The second reading of this notice will be held January 3, 2023.

### HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board and Sandy Dinger, Highway Secretary met via Zoom to Discuss Highway Department business. Hofland informed the board that the highway department has been working on clearing roads pushing snow back from roads to make room for the next snow event. Dinger informed the board that they have received approval from the State for the 5-year plan. Knebel moved, Jones seconded to reapply for Structure 46-151-000 located 10 miles North and 3.1 miles East of Britton on 100<sup>th</sup> St as the initial BIG grant was not sufficient to cover the replacement cost to mitigate the cost difference. The County proposes to contribute 35% toward the grant costs. All members present voted aye. Hofland informed the board that Chuck Fromelt with SDDOT will meet with the two townships that applied for the small structure funding grant to complete the necessary paperwork on January 5.

Marie Marlow met with the board representing the Marshall County Food Pantry. The food pantry has served 1,209 families from January-November 2022. When the food pantry holds their annual re-organization meeting in February, they will reduce the number of board members. A Commissioner will no longer serve on the board, instead the Food Pantry will report to the Commissioners once a year.
