Dustin Hofland, Highway Superintendent met with the board and Sandy Dinger, Highway Secretary met via Zoom to discuss Highway Department business. Hofland reported that the highway department has been working on snow removal and clearing snow farther away from roadways. Hofland asked that the board begin considering what potential projects they would like to plan to complete this year. Potential projects being discussed include: Chip Sealing 16AC, 16AE, 1AS; Base 1 injection and Magnesium Chloride on County Road 12A and County Road 4AE near the gravel pit; bridge on County Road 2GC – Bridge 46-141-000 (BIG grant reapplied for); finishing the Eden Project-county road 12 GE; building up County Road 13G gravel.

Hofland also informed the board that the blade at the Britton shop has many repairs needed and the board will need to be decide whether to make these repairs or replace the blade soon as it has high hours and is the next blade scheduled to be replaced.

Luttrell moved, Medhaug seconded to award a \$75,200 Rural Access Infrastructure Grant to Waverly Township. All members voted aye.
