# **DIRECTOR OF EQUALIZATION:**

Kassi Jones, Director of Equalization met with the board to inform them that valuations for all types of property except Ag land will be increasing 10-25% this year due to the sales ratio coming in too low. The State requires that property values be at least 85% of recent sales. Marshall County's values came in at about 71%. Jones was required to revalue properties to meet the State rule. Property owners will receive their assessed value notices in the mail in the coming weeks.
