PERSONNEL POLICY:

The board discussed the travel portion of the Marshall County Personnel Policy as it pertains to overtime. Knebel moved, Medhaug seconded to make the following change to the policy and make this change retroactive to January 1, 2023 (change noted with a strikethrough):

2-5 TRAVEL: Travel authorization to conduct official County business outside of the county must be obtained beforehand from the County Commission. Expenses for travel shall include meals, lodging and automobile costs incurred except that reimbursement for meals shall not exceed forty (\$40.00) dollars per day. The employee shall be responsible for obtaining lodging whereby the costs will be to the advantage of the County. A county vehicle is available for county employee use to attend meetings/training. Employees wishing to use this vehicle shall contact the Auditor's office. Reimbursement for the use of the employee's personal automobile in the performance of authorized County business shall be set at state rates for each mile when a county vehicle is available. When a county vehicle is not available, mileage reimbursement rate shall be set at federal rates. When employees are required to attend a workshop and drive their own vehicles, they will be reimbursed for travel expenses and regular pay will be paid for those hours spent driving

and attending the workshop. These hours will not count toward overtime calculation. The employee shall be responsible for submitting and maintaining detailed receipts for lodging and other expenses, and shall keep a record of miles traveled.

All members voted aye.

COURTHOUSE PROJECT:

Josh Muckenhirn, ISG met with the board and Tobin Morris, Colliers International met via Zoom to discuss the Courthouse project. The project is estimated to cost a total of \$8.9-\$9.6 million. The board discussed funding and has set aside some money to out toward the project. In light of this, Jones moved, Knebel seconded to ask Morris to draft a ballot question for a June 6 election for a \$5 million bond to help fund the project. All members voted aye. The board will discuss the ballot question at their April 11 Commissioner meeting.

The board also discussed the timeline for sharing information with the public and encouraging residents to vote. There will be public meetings, articles in the newspaper, and various other media releases in the coming months to keep the public well informed of the project prior to the election.

FUTURE MEETINGS:

The board set the following dates for future meetings: April 11 & 25, with the possibility of adding April 18 if needed for Equalization appeals.

TRAVEL:

Knebel moved, Medhaug seconded to authorize the following travel expenses: Jennifer Ringkob to Watertown for a 4-H DASH meeting May 25, to Aberdeen for a Spring Conference March 28-30, to Warner for an AI clinic May 7, to Watertown for a Northeast Advisor Collaboration April 19 & May 17, and to Brookings for a Teen Leadership Conference June 5-9; Tanner Schiferl to Pierre for a Rural Investigation Training March 13-16; Logan Roehr to Pierre for EM 102 class April 20 and EM 103 Class May 11; Linda Haaland to Pierre for Spring Workshop April 12-13; Matt Schuller, Doug Medhaug and Leron Knebel to Pierre for Spring Workshop April 19-20; Matt Schuller, Leron Knebel, Megan Biel and Kalissa Stelzer to Webster April 5 for Lake Region District Meeting. All members voted aye.

NEW HIRE:

Ridge Oliver and Slade Owen were hired as Deputy Sheriffs effective March 20 at a rate of \$20/hour. Knebel moved, Medhaug seconded to authorize the chair to sign Marshall County Sheriff's Office Employment Agreements for Oliver and Owen. All members voted aye.

INMATE HOUSING:

Knebel moved, Jones seconded to authorize the chair to sign an inmate housing agreement with Day County. Housing rates will be \$75/day for an unsentenced detainee and \$50/day for a sentenced inmate. All members voted aye.

EMERGENCY MANAGEMENT:

Logan Roehr, Emergency Manager met with the board via Zoom to discuss various items. The board asked about other counties recently making disaster declarations. Roehr informed the board

that Marshall County did not have enough utility damage to meet the threshold requirements to be able to declare a disaster. Roehr plans to inspect the Hillhead tower as he has been informed by Minnkota that it is due for a replacement/upgrade. He is also looking into adding a frequency/repeater for the Highway department so that they have their own instead of sharing with the civil defense frequency.

AUDIT CLOSING CONFERENCE:

Christopher Theroux, Department of Legislative Audit, met with the board to inform them that the 2020-2021 audit had been completed. Knebel moved. Jones seconded to authorize the chair to sign the Letter of Representation. All members voted aye. Knebel moved, Medhaug seconded to authorize the chair to sign the Letter of Governance. All members voted aye. Jones moved, Luttrell seconded to authorize the chair to sign the Management Letter and Findings. All members voted aye. The full report can be viewed in the Auditor's Office during normal business hours or on the Legislative Audit webpage.
