The Pledge of Allegiance was recited by everyone in attendance. Jerry Burger was present. Sandy Dinger, Kalissa Stelzer and Shelby Thompson were present for portions of the meeting via zoom.

AGENDA:

Jones moved, Medhaug seconded to approve the agenda for May 23, 2023. All members present voted aye.

EXECUTIVE SESSION:

Medhaug moved, Knebel seconded to enter into executive session to discuss personnel issues at 8:33 am. All members present voted aye. The chairman called the board out of executive session at 9:03 am.

PUBLIC COMMENT:

Glen Aldentaler was present to make public comment regarding the drainage application process. The board informed Aldentaler that according to the Marshall County drainage ordinance, drainage applications must be advertised before they can be discussed. Aldentaler has a drainage application that will be advertised and scheduled to be heard once it is turned into the drainage administrator.

ADMISSION OF SERVICE:

Knebel moved, Medhaug seconded to authorize the chair to sign an admission of service for a legal matter in which Marshall County has a taxing interest. All members present voted aye.

ZOOM:

With the end of the Covid Pandemic being declared, the board discussed discontinuing holding Commission meetings via Zoom. The current equipment used for zoom meetings is not sufficient and would need to be replaced if zoom meetings are continued. The board plans to terminate Zoom meetings effective July 1, pending further discussion from constituents.

HIGHWAY:

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary met with the board to discuss Highway Department business. Hofland reported that the Highway Department has been working on signing and pulling the weight limit postings off of county roads. Jones moved, Medhaug seconded to accept the bid from Bituminous paving from April 25 for the Chip seal project on 16AC (11 miles), 16AE (12.5 miles) and 1AS (2 miles) for \$1,334,361.50. All members present voted aye.

PAY RAISE/BONUS:

Jones moved, Medhaug seconded to approve the following pay raises: Duane Kronbach from \$18.10/hr to \$20.00/hr; Barry Braaten from \$18.10/hr to \$20.00/hr; Kevin Kraft from \$19.84/hour to \$20.00/hr; and Adam Okroi from \$19.64/hr to \$20.00/hr effective May 7 and to give a \$4,000.00 bonus to all current highway laborers who worked during the 2022-2023 winter season. This includes Duane Kronbach, Barry Braaten, Kevin Kraft, Adam Okroi, Monte Hoglund, Larry West, Jim Stickland and Dustin Hofland. (This motion was previously seconded and voted on by Knebel and had to be re-motioned and seconded later in the meeting due to the nepotism policy and Knebel needing to abstain.) Schuller, Medhaug and Jones voted aye, Knebel abstained. Motion passed.

FUEL QUOTES:

Sandy Dinger received the following quotes for unleaded gasoline for the Britton shop on May 4: Damar Elevator \$3.10; Eden Oil \$2.86; Full Circle Ag \$2.87. Gasoline was delivered to the Britton Shop by Eden Oil.

EMERGENCY MANAGEMENT:

Logan Roehr, Emergency Manager met with the board to present a report on the damage that has been reported for the disaster declaration. \$347,286.50 in damages within the county were reported by townships, Marshall County and Upper Crow Creek. A disaster declaration determination is expected from the federal government in the next 4-5 weeks. The damage reported information is available from the Emergency Manager if anyone is interested in viewing it.

Randy Maddox, Regional Emergency Management Coordinator, met with the board to discuss the Local Emergency Management Program Grant offered by the state. Marshall County has not participated in this grant since 2016, but will consider participating again as the grant repays a portion of the emergency Managers salary as long as certain criteria are met.

GROW SD:

Mark Nelson, Grow, SD met with the board to present a report on Grow SD's activities in Marshall County and to request ongoing support. In 2022, over \$2.9 million dollars was invested in Marshall County through Grow, SD.

LIQUOR LICENSE TRANSFER:

Medhaug moved, Jones seconded to approve a Malt Beverage and SD Farm Wine license transfer from Clear Lake Investments, LLP to Holly Wismer. All members present voted aye.

SECOND READING:

Knebel moved, Medhaug seconded to pass the following ordinance at this, its second reading: MARSHALL COUNTY, SOUTH DAKOTA REVISED ZONING ORDINANCE. The ordinance can be viewed in its entirety on the County website or in the Zoning office during regular business hours. All members present voted aye.
