The Board of County Commissioners met in regular session at 9:00 a.m. on December 5, 2023 at the Marshall County Courthouse. Members present were Knebel, Schuller, Jones and Medhaug. Commissioner Luttrell was absent. Commissioner Schuller presided. State's Attorney Victor Rapkoch was present. The meeting was open to the public. The Pledge of Allegiance was recited by everyone in attendance.

## **AGENDA:**

Medhaug moved, Knebel seconded to approve the agenda for December 5, 2023. All members present voted aye.

## **MINUTES:**

Jones moved, Medhaug seconded to approve the minutes for November 21, 2023. All members present voted aye.

## **PUBLIC COMMENT:**

No one was present to make public comment.

# **UTILITY LOCATION:**

Jones moved, Medhaug seconded to approve a quote from Blood Hound for \$3,432 to locate all utilities on the Courthouse lot. All members voted ave.

## ALCOHOLIC BEVERAGE LICENSE RENEWAL:

Knebel moved, Jones seconded to approve Retail (on-sale) and Package (off-sale) liquor license renewals for Todd's Tavern. All members present voted aye.

#### **SECOND READING: Flood Ordinance**

Erin Collins-Miles, Zoning Director and Ryan Patterson, Upper Crow Creek were present for the discussion of the Second Reading of the Flood Ordinance that FEMA is requiring Counties to pass in order for individuals in a floodplain to receive a federally backed loan. The maps proposed by FEMA are still not finalized and will not be finalized until December 21. The second reading will remain postponed.

## **HIGHWAY:**

Dustin Hofland, Highway Superintendent met with the board to discuss Highway Department business. Hofland informed the board that the department has been working on finishing mowing ditches. Logan Roehr, Emergency Manager was present to discuss winter road closures. Roehr informed the board that the State 511 system will now allow the State and County to mark roads as closed. This should carry over to navigation apps to prevent motorists from being directed to drive on roads that are impassable. Roehr and Hofland will work together to learn how to log in to this site and make these designations. The board approved the advertisement of

a budget supplement hearing for the highway department of \$860,000. The hearing will be held December 19.

#### **TRAVEL:**

Jones moved, Knebel seconded to authorize the following travel expenses: all highway department employees to MSHA annual refresher in Aberdeen February 13 & 14 or Sisseton February 27; Ian MacDonald, Austin Steiner and Dave Hunter to Sisseton for ARIDE training November 15 & 16. All members present voted aye.

## **EMERGENCY MANAGEMENT:**

Logan Roehr met with the board to discuss insurance on the drone. Jones moved, Medhaug seconded to proceed with insurance coverage at \$646.88 for liability and property coverage. All members present voted aye. Roehr also discussed back up options for a point of contact for emergency situations if Roehr is out of town. Roehr will talk with other Emergency Managers and report back to the board. Roehr also informed the board that he had been informed of potential legislation that would make the Emergency Management position a state employee split out into regions rather than a county employee. Roehr will continue to track this legislation.

#### **E911 DISPATCH:**

Deb Skonberg met with the board to inform them that Bailee Yule has been hired as a dispatcher at a rate of \$19.50/hour.

#### **EXECUTIVE SESSION:**

Knebel moved, Medhaug seconded to enter into executive session at 10:47 am to discuss legal matters. The chairman called the board out of executive session at 11:26 am. No action was taken.

#### **SHERIFF VEHICLE:**

Medhaug moved, Knebel seconded to approve payment of \$9,000 to Custom Installation Solutions to outfit the Sheriff's department pick up for duty. All members present voted aye.

Jones moved, Medhaug seconded to approve the second reading of the Ordinance 63.
