GENERAL COMMENT:

The petitioner is requesting to Rezone the above-described proposed lot in order to create a new lake lot without shore frontage. Currently, the land sits empty (no structures). The land cannot be platted prior to the Rezone as there can only be one Zoning classification on a parcel of land. The Rezone would make the land conform with other surrounding Zoning and bring it into compliance with the same use as other surrounding property. The property is currently Zoned Agricultural.


