PUBLIC COMMENT:

David Finley, Clear Lake, made public comment about a building he has placed on his lot that has an eave that is 16 inches over the setback line, while the building itself meets setbacks. The building permit will go before the board at the next meeting.

HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board to discuss highway department business. Hofland informed the board that the department has been working on blading, hauling gravel and have completed the remaining small structure inventory. They are currently down to 1 truck driver and are looking into contracting with local companies for trucking. Lillian Good-Morrell was hired effective May 28 to clean and mow at the highway shop at \$16/hour. Hofland also reported that the chip seal, fog seal and paint has been completed on County Road 16AE/AC. Milling on county road 12A is set to begin mid to late July. The Hillhead road (06A) also needs to be marked and patched once they move the hot mix plant to Waubay. Marshall County received \$6,117.35 from SD DOT for pavement marking and \$223,128.96 for SDBGP payout. Highway Secretary Sandy Dinger also made a report to the board of records being destroyed according to the 2009 Records Retention and Destruction Schedule Manual, the complete list to pe published at a later date.

SURPLUS:

Medhaug moved, Bender seconded to declare the following property surplus: S1/2 of Lots 6, 7 & 8 & All of Lots 11 & 12, Block 2, Stuarts Addition, Britton. This property will be sold by live auction on July 16. All members present voted aye.

PARAMEDIC UTILIZATION:

Nick Fosness and Toni Mattson, Marshall County Healthcare Center, and Pam Bard, Lori Amerman and Logan Roehr, Marshall County Ambulance met with the board to discuss paramedic utilization on the Ambulance. Fosness and Mattson reported that Roehr has acted as a paramedic employee of the hospital on 10 ALS ambulance transfers since the last time this subject was discussed and everything has gone well. A doctor has reviewed these transfers and felt they went as they should have. Fosness and Mattson encouraged the ambulance to utilize Roehr's paramedic capabilities in initial response situations. Amerman and Bard expressed reluctance and concerns with doing this and with the additional medicines and liability that the ambulance/Roehr would be responsible for. The board asked that Roehr along with Amerman and Bard come up with plans and policies to begin to implement paramedic services on initial ambulance responses and report back to the board with these plans for discussion. The board also asked that the ambulance advertise for additional EMT's and classes offered for EMT's. Auditor Biel will talk with the newspaper about writing a story on the volunteer ambulance service.

WELFARE:

Linda Haaland, Welfare Director met with the board to present a welfare request. Medhaug moved, Bender seconded to approve a welfare claim for \$333.82 to Ottertail Power company. All members present voted aye.

E911 COMPLIANCE REVIEW:

Deb Skonberg, E911 Coordinator met with the board to inform them that the State Coordinator has reviewed the E911 department and Marshall County was found to be in full compliance. The next review is not due until 2027.

SHERIFF:

Sheriff Swanson met with the board to introduce Deputies Austin Steiner and Ridge Oliver to the board.

EXECUTIVE SESSION:

Medhaug moved, Knebel seconded to enter into executive session at 11:40 am to discuss personnel issues. The chairman called the board out of executive session at 12:15 pm. The following action was taken.

Medhaug moved, Knebel seconded to authorize the Sheriff to hire an additional deputy, with the understanding that other budget cuts may need to be made in order to make this work in the current budget. All members present voted aye.

ELECTION CANVASS:

The board canvassed the votes for the June 4, 2024 Primary Election. Knebel moved, Medhaug seconded to authorize the board to sign the official canvass report. All members present voted aye. The drawing of precincts for the post-election audit was completed. Precinct 4 was selected first. Since there were less than 100 ballots cast in that precinct, another precinct was required to be drawn in addition to Precinct 4. Precinct 1 was then selected. The post-election audit of Precincts 4 and 1 will take place on June 12 at 1:00 pm in the Commission Meeting Room.

ABATEMENT:

Bender moved, Knebel seconded to abate the taxes on parcel 30.53.13.3800. Reason: This was a mobile home that was taken on tax deed a number of years ago and then was sold for \$1 in December 2022. Total Taxes: \$2,729.12. All members present voted aye.
