PUBLIC COMMENT:

No one was present to make public comment.

HIGHWAY:

Dustin Hofland, Highway Superintendent meet with the board to discuss highway department business. Hofland reported that work on county road 12 is planned to begin on August 1. The highway department has been working on blading, hauling gravel and has begun to do some mowing.

Knebel moved, Luttrell seconded to approve a boring permit for Lake Region Electric Association in County Roads 12 and 5. All members voted aye.

The board was given the May highway department budget report prepared by Sandy Dinger. Knebel moved, Medhaug seconded to pass the following Resolution:

WHEREAS, Marshall County has authority to establish speed zones upon all or any part of highways under its jurisdiction pursuant to SDCL 32-25-9.1;

WHEREAS, Marshall County has jurisdiction of 101st Street as it is part of the County Highway System;

WHEREAS, there has been a request by residents north of Veblen that Marshall County establish a 40-miles-per-hour speed zone for trucks on County Highways north of Veblen due to the increased traffic of trucks for a gravel/rock project in North Dakota,

WHEREAS, the Commissioners find that it is appropriate and best for public safety to have a slower speed zone for trucks for parts of 101st Street and 446th Avenue, also known as Marshall County Highway 1 and 2,

NOW, THEREFORE, BE IT ORDAINED BY THE MARSHALL COUNTY BOARD OF COMMISSIONERS AS FOLLOWS:

A 40-mile-per-hour speed zone for trucks will be established on Marshall County 446th Avenue, also known as Marshall County Highway 1, to begin on July 9, 2024, starting at the north city limits of Veblen and ending at 100th Street (the North Dakota Border) when going south to north on 446th Avenue, and starting at 100th Street (the North Dakota Border) going to the north city limits of Veblen when going north to south on 446th Avenue. A map has been provided for clarity.

A 40-mile-per-hour speed zone for trucks will be established on Marshall County 101st Street, also known as Marshall County Highway 2, to begin on July 9, 2024, starting at 441st Avenue and ending at 449th Avenue when traveling from the west to east on 101st Street, and 40-mile-per-hour speed zone starting at 449th Avenue and ending at 441st Avenue when going east to west on 101st Street. A map has been provided for clarity.

The Marshall County Highway Department shall conspicuously post the appropriate mile-perhour speed zone signs at the beginning and end of each speed zone as mandated by 32-25-9.1.

All members voted aye.

Medhaug moved, Luttrell seconded to declare approximately 2500 gallons of #2 dyed diesel fuel surplus and offer it for sale by sealed bids. All members voted aye.

Bender moved, Medhaug seconded to approve an approach permit pending inspection by Hofland on County Road 5. All members voted aye.

FUEL QUOTES:

Sandy Dinger, Highway Secretary received the following quotes for #2 Diesel fuel for the Langford Shop on June 18: Damar Elevator \$2.77, Eden Oil \$2.75, Full Circle Ag \$3.009, Holland Bros. \$2.88. Dinger received the following quotes for gasoline for the Britton Shop on June 18: DaMar Elevator \$2.92, Eden Oil \$2.88, Full Circle Ag \$2.895. Gasoline was delivered to the Britton Shop by Eden Oil.

SPECIAL LIQUOR LICENSE:

Luttrell moved, Bender seconded to approve a special one-day liquor license for the Britton Shrine Club to serve alcohol at a wedding at Fort Sisseton August 10. All members voted aye.

WHEREAS, SDCL 12-14-1 states the board of county commissioners shall by resolution provide for election precincts throughout its county and shall designate polling places within such precincts, and

WHEREAS, a General Election will be held in 2024 for the purpose of electing candidates;

NOW THEREFORE BE IT RESOLVED, that the Marshall County Board of Commissioners hereby adopts the following precincts for the 2024 General election.

Luttrell moved, Knebel seconded to deny a previous employee's request that accrued vacation be paid out although the 5-year employment period per the personnel policy had not been met. 4 members voted aye, 1 member voted nay. Motion carried.

RESIGNATION:

The board accepted a letter of resignation from Bailee Yule, E911 Dispatcher effective July 24.

RECESS:

Medhaug moved, Bender seconded to recess for lunch.

RECONVENE:

The board reconvened at 1:30.

FEMA FLOODPLAIN ORDINANCE:

The board met via Zoom with FEMA representatives Stephanie DiBetitto, Madi Pluss, Marc Macy and Matt Buddy. Mike Atkinson, Upper Crow Creek, Erin Collins-Miles, Floodplain Administrator, and Victor Rapkoch, State's Attorney were present. Various questions about the proposed floodplain ordinance were discussed.
