Medhaug moved, Knebel seconded to approve 2 boring permits for Lake Region Electric. All members voted aye.

EXECUTIVE SESSION:

Medhaug moved, Knebel seconded to enter into executive session to discuss personnel issues at 10:07 am. All members voted aye. The chairman called the board out of executive session at 10:26 am. The following action was taken in regular session: Luttrell moved, Bender seconded to deny a request to reconsider the motion made on July 9, 2024 that denied a former employee's request for accrued vacation to be paid out although the 5-year employment period per the personnel policy had not been met. The previous motion stands. All members voted aye.

FIRST READING: Revised Zoning Ordinance

Knebel moved, Medhaug seconded to approve the revised zoning ordinance at this, its first reading. All members voted aye. The second reading will be held September 10.

COVID POLICY:
