PUBLIC COMMENT:

No one was present to make public comment.

HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board to discuss Highway Department business. Highway laborers are working on mowing, and still have patching to do, but are waiting for Bituminous Paving for hot mix. The 2024 Bridge Inspection reports are not prepared yet, but Hofland hopes to know more about potential repair requirements next week. State officials have contacted Hofland about wanting to redo the Roy Lake road. They have asked that Marshall County pay 25% of this estimated \$3 million cost next year. The board asked that Hofland inform the State Game, Fish and Parks that this is not in the budget for 2025. The board discussed the different items that have been applied to County Road 4AE and the area near Sunset Colony (11AN). County Road 4AE has Base One injected and milled in. This stabilizes the road and helps prevent breakup, and then Magnesium Chloride was applied to the top for

dust control and additional stabilization. Near Sunset Colony, Louiseau Construction applied Magnesium Chloride as part of the haul road agreement for dust control.

CANVASS:

The board canvassed the votes for the November 5, 2024 General Election and signed the official canvass report. No errors were found. The official report will be sent to the Secretary of State for the State Canvass to be held on November 12, 2024. The drawing of precincts and races for the post-election audit was completed. Precinct 7 was selected, then Initiated Measure 29 and County Commissioner District 4 were selected to be audited. The post-election audit will take place on November 13 at 1:00 pm in the North Marshall Firehall Meeting Room.

TREASURER RETIREMENT:

The Marshall County Commissioners would like to express their sincere gratitude to Pam Oelkers for her years of service to Marshall County as Deputy Treasurer and Treasurer and wish her the best in her retirement.

TREASURER APPOINTMENT:

Per the retirement of Treasurer Pam Oelkers effective November 8, Medhaug moved, Luttrell seconded to appoint Treasurer-Elect Amanda Streier as Treasurer effective November 11 at a salary of \$50,000/year. All members voted aye.

RESIGNATION:

The board accepted the resignation of Becky Wade, E911 Dispatcher effective October 28.

ARPA FUND CLARIFICATION:

Luttrell moved, Knebel seconded to clarify the intent of the motion to use ARPA funds made on September 19, 2023 to state that funds were used from January 2022 until fully expended for General Fund salaries and benefits. All members voted aye.

Medhaug moved, Bender seconded to approve a liquor license renewal for Prairie Sky Game Ranch and Guest Lodge and Britton Country Club. All members voted aye.
