Sorry I didn't get back to you sooner.

Like I was telling you over the phone, that this is a one time specific "ok" from the state. Any other modifications that were to deviate from the standard zoning rules need to be requested in a separate case by case situation. In short, this is to not set a precedence for future cases. If the shed were to be in lot 12a we would have an objection. We expect that the location of the structure would not interfere with use of the road right-of-way for utilities or park maintenance.
