PUBLIC COMMENT:

No one was present to make public comment.

NECOG:

Eric Senger and Lesleann Palmer, NECOG, were present to give the board an overview of different services offered by NECOG and to go over the 2024 performance report.

HIGHWAY:

Dustin Hofland, Highway Superintendent and Sandy Dinger, Highway Secretary were present to discuss Highway department business.

Paul Stahl, Raymond Stahl, Tim Stahl, Westwood Colony were present to discuss County Road 4 from County road 9 going 2 miles west to 421st Avenue. They stated that the road is in bad shape and is causing damage to their vehicles and equipment. They would like to see the road paved. Hofland estimated that it would cost \$350,000 per mile plus the cost of reconstructing the road to pave these two miles or approximately \$50,000 per mile plus gravel. The board requested the NECOG look into funding options for improving this road.

The board asked Dinger to provide an overview of the current Highway Software and whether the software should be upgraded to better suit the County's needs. Dinger state that she is happy with the current system, as it provides the required documentation for Legislative Audit. Bender moved, Medhaug seconded to purchase the 6175R John Deere tractor that the County had been leasing for \$32,239.51. All members voted aye.

SURPLUS:

Medhaug moved, Luttrell seconded to declare the following items surplus and sell them on Big Iron auction service on March 12: 2012 belly dump trailer, 2007 rotary mower, 1994 Ford F150, 2008 boom mower, homemade roller, misc. tires (used), power washer, payloader grapple, 3 monroe sander boxes, 275 gallon weed sprayer. All members voted aye.

EMERGENCY MANAGER:

Logan Roehr, Emergency Manager met with the board to inform them of a training that he has requested to attend in Pierre as part of the LEMP Grant. He also spoke about a change in ownership of the pipeline that runs through Marshall County. The former Transcanada pipeline is now owned by Southbow. Roehr has several meetings scheduled with Southbow to go over pipeline safety. Roehr spoke about the siren in Britton not currently working because of the construction at the courthouse. The County will work with the site superintendent to ensure that this is repaired prior to storm season.

Medhaug moved, Luttrell seconded to approve the Local Emergency Operations Plan as presented. All members voted aye.

VETERAN'S SERVICE OFFICER:

Dave Daberkow, VSO met with the board to give an update for July-December 2024. Daberkow reported that 5 new compensation claims were filed in this period along with other duties. He also attended the annual recertification school.
