The Marshall County Planning & Zoning Board met at 9:00 AM, February 4, 2025, at the North Marshall Firehall Meeting Room. Present at the hearing were the following Board members; Matthew Schuller, Doug Medhaug, Jason Bender and Lynda Luttrell. Commissioner Kilker was present via telephone. Commissioner Schuller presided. Others present at the hearing were Erin Collins-Miles, Planning & Zoning, Megan Biel, Auditor, Victor Rapkoch, Marshall County States Attorney and Sandy Dinger. Eric Senger and Lesleann Palmer with NECOG were present for a portion of the meeting.

AGENDA:

Bender motioned; Luttrell seconded to approve the agenda. All members voted aye. Motion carried.

MINUTES:

Medhaug motioned; Luttrell seconded to approve the minutes from December 31, 2024. All members voted aye. Motion carried.

DRAINAGE:

Pertaining to an application for CNH Farms, LLC by Nick Heitmann; Discussion regarding the direction and flow of water under the state highway took place; noting that the SDDOT had no issue with the project. Medhaug motioned; Bender seconded to approve an application to drain on the property described as Lots 1 and 2 of the N1/2NE1/4; and the S1/2NE1/4, with exceptions, of Section 3, T126N, R54W. Conditions to this permit are as follows; to make the construction completion date as seen on permit application; April 1, 2027. Applicant must reapply after said date. Applicant must follow all applicable laws. A roll call vote was taken; Medhaug – Aye, Luttrell – Aye, Bender – Aye, Kilker – Aye, Schuller – Aye. Motion carried.

PLAT:

Bender motioned; Kilker seconded to approve the following plat; Plat of Price 1st Subdivision in Hickman Township. A roll call vote was taken; Medhaug – Aye, Luttrell – Aye, Kilker – Aye, Bender – Aye, Schuller - Aye. Motion carried.

BUILDING PERMITS:

Medhaug motioned; Luttrell seconded to accept a building permit for the following applicant: Dale Pitzl – Lake Township. All members voted aye. Motion carried.

OTHER:

Collins-Miles and Rapkoch updated the Board on a Marshall County resident who has failed to obtain a building permit prior to construction of a building. Efforts to contact the resident to create a solution are still underway. Updates will be provided as any progress is made on the matter.

A brief update on E911 Addressing projects that are worked on in the winter months was given. The review of parcels within Marshall County that do not have an E911 address on file continue to be worked on and completed. Work on this project will continue in the hopes that all parcels will be accurately addressed, if needed. Any questions can be directed to the E911 Addressing Administrator. Additionally, Dinger briefly discussed an address and road sign relating to a phone call she received regarding a road out at Roy Lake.
