

MARSHALL COUNTY ORDINANCE NO. 4

AN ORDINANCE REGULATING REFUSE DISPOSAL AT THE MARSHALL COUNTY LANDFILL SITE.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MARSHALL COUNTY, SOUTH DAKOTA, AS FOLLOWS:

Section 1. Definition of Terms. "Solid waste" shall include every accumulation of animal, vegetable, or other material resulting from the preparation and consumptions of eatable food stuffs or resulting from decay, deãding in or storage of meats, fish, fowl, fruits or vegetables including the cans, containers or wrappers wasted along with such materials or such industrial, domestic or organic solid wastes, or residues of animals sold for meat, or fruit, vegetables and animal matter from kitchens, dining rooms, markets, food establishments or any other place using, dealing in or handling meats, fish, fowl, fruits, vegetables or grains or offal, animal excretion or the carcasses of animals, fish or fowl, and any other material which is placed by its owner, user or consumer or manufacturer or distributor for disposition in the solid waste management disposal system of the County, or any other material as may be defined as solid waste by the laws of the State of South Dakota or the regulations of the Department of Environmental Protection of the State of South Dakota now or at any-time hereafter.

Section 2. Refuse Disposal Sites. The hours that the Marshall County Landfill Site is open to the public shall be those that are posted at such sites or as may be published in one of the official County newspapers. No person other than the authorized Marshall County Landfill Site operator or authorized government employee shall trespass or be on a refuse disposal site area during the hours of closure as designated on signs posted at the site. No dumping at the site shall be permitted or allowed without obtaining permission from the Marshall County Landfill Site Operator or his authorized agents.

- Section 3. Littering. No person, persons, firm, partnership, or corporation shall dispose of any of the materials as set forth in Section 1 anywhere in the County except as the landfill and shall make no such disposition without permission. Anyone littering at the Marshall County Landfill Site shall be subject to the penalty or penalties provided.
- Section 4. Scavenging and Salvaging. Scavenging or salvaging at County Refuse disposal sites without the expressed permission of the Marshall County Landfill Site Operator or his authorized agent is prohibited.
- Section 5. Dumping Where Marshall County Landfill Site Operator Designates. No person, firm, or corporation, or their representatives, shall place or dump any refuse at a place within the refuse disposal site other than where the Marshall County Landfill Site Operator shall so designate.
- Section 6. Penalty. Any person, firm, or corporation who shall violate any of the provisions hereof shall be guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine not to exceed One Hundred Dollars (\$100.00) or by imprisonment in the County jail for a period not exceeding thirty (30) days, or by both such fine and imprisonment.
