HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board to discuss highway department business. Ryan Patterson, Upper Crow Creek was present. Chelsey Sheridan, IMEG was present to discuss the 2025 Marshall County Bridge Inspections that have been completed so far. 24 bridges are scheduled to be inspected this year. There are 3 bridges that have not yet been inspected. Two bridges so far are recommended to have the load limit reduced. Bridge 46-060-168 in 418th Avenue will go from 12T-20T down to 5T-5T. Bridge 46-100-171 in 422 Avenue will go from 14T-24T down to 12T-20T. Sheridan will put together a prioritization of the bridges for the Commissioners to help with planning in the future.

Kilker moved, Luttrell seconded to authorize the chair to sign the Joint Powers Agreement with the State for Preliminary Engineering on Bridge 46-100-171. All members voted aye. Medhaug moved, Bender seconded to authorize the chair to sign the Joint Powers Agreement with the State for Preliminary Engineering on Bridge 46-098-130. All members voted aye. Luttrell moved, Medhaug seconded to authorize the chair to sign the Joint Powers Agreement with the State for Preliminary Engineering on Bridge 46-116-120. All members voted aye. The Highway Department 5-year Plan Meeting will be held September 17 at 7:00 pm at the North Marshall Fire Hall.

2026 BUDGET:

Sheriff Swanson met with the board to discuss the 2026 budget. No action was taken. The annual budget hearing will be held on September 30.

NEW HIRE:

Kassi Jones was hired as a shared full-time deputy between the Treasurer's and Auditor's office at a rate of \$20/hour (taking into consideration previous County office experience) effective September 15. Bill Deutsch was hired as part-time (over 20 hours/week) County Building Maintenance at a rate of \$20/hour effective September 6.
