Luttrell and Bender mentioned various items they would like added to the next meeting agenda including a storage space for County Maintenance equipment and a 4H fundraising opportunity.

FIRST READING: Ordinance 73

Kilker moved, Luttrell seconded to approve Ordinance 73 at this, its first reading.

ORDINANCE NO. 73

AN ORDINANCE IMPOSING A COUNTY WHEEL TAX AND PROVIDING FOR THE ADMINISTRATION AND COLLECTION THEREOF.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF MARSHALL COUNTY, SOUTH DAKOTA, AS FOLLOWS:

WHEREAS, pursuant to SDCL, Chapter 32-5A, Marshall County has the authority to impose a wheel tax on all motor vehicles including trailers, as defined in SDCL 32-3-1, registered in the County; and

WHEREAS, the Board of County Commissioners of Marshall County, South Dakota deems it necessary for the purpose of promoting the health, safety, and general welfare of the County, to impose a wheel tax on all vehicles registered in the county;

WHEREAS, the Board of County Commissioners are responsible for establishing a means for distributing the revenue generated by this wheel tax;

NOW, THEREFORE BE IT ORDAINED, that a county wheel tax is hereby imposed upon all motor vehicles as defined by SDCL 32-3-1 registered in the County at the rate of Five and no/100 (\$5.00) Dollars per vehicle wheel. Such wheel tax shall be the same for all types of motor vehicles and the total wheel tax shall not exceed Sixty and no/100 (\$60.00) Dollars, per vehicle. Such wheel tax shall be administered and collected by the County, and 100% proceeds from such wheel tax shall be retained by the County, deposited in a special highway fund 201,

and the revenue shall be used only for highway and bridge maintenance and construction. If a motor vehicle is licensed for a period of time less than twelve (12) months, the wheel tax shall be prorated on a monthly basis.

This Ordinance shall become effective January 1, 2026. Once this ordinance takes full effect, Marshall County Ordinance Number 30 is hereby REVOKED.

All members voted aye. The second reading of Ordinance 73 will be held on November 4.

HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board to discuss Highway Department business. Bender moved, Luttrell seconded to approve an extension to the construction time line for BX Civil & Construction for Bridge BRO 8046(00)24-1. All members voted aye. Hofland informed the board that the striping on County Road 5AC (Fort Road) should be completed this week.

PLAT VACATION:

Bender moved, Kilker seconded to pass the following resolution to approve the vacation of a Plat: WHEREAS, a Petition for the Vacation of a Plat has been presented to the Marshall County Board of Commissioners. Said Plat petitioned for vacation is described as:

Plat of Gibson First Cottonwood Lake Addition in Government Lot 1 of Section 4 T126N, R54W of the 5th P.M., Marshall County, South Dakota; as filed in Plat Book 6 page 81 on the 20th day of December 2022.

WHEREAS, Tim D. Steiner and Sheila R. Steiner has signed the Petition for vacation of a Plat indicating that they have reviewed the Petition and consent to the vacation of the plat described in the petition.

WHEREAS, petitioners agree to dedicate an easement for the purpose of ingress/egress for maintenance of any public utilities which may occupy the existing right-of-way at the time of this action.

WHEREAS, pursuant to public notice, hearing was held before the Board of County Commissioners on the 28th day of October, 2025 at 9:30 am, at which time the Petition for vacation was submitted for examination and no protest having been made, motion was made and seconded that the following Resolution be adopted:

BE IT RESOLVED that the plat described above shall be and is hereby vacated, and the County Auditor is hereby authorized and directed to certify this Resolution as a matter of record.

All members voted aye.

ALCOHOLIC BEVERAGE LICENSE RENEWAL:

Kilker moved, Medhaug seconded to approve a Retail (on-sale) Liquor license renewal for Chinatown, LLC and a Retail (on-sale) and Package (off-sale) Liquor license renewal for Todd's Tavern. All members voted aye.

EMERGENCY MANAGEMENT:

Logan Roehr, Emergency Manager met with the board to give a quarterly update. Medhaug moved, Kilker seconded to authorize the chair to sign the Quarterly LEMPG report. All members voted aye.

COURTHOUSE PROJECT UPDATE:

Deb Skonberg, E911 Coordinator and Sam Swanson, Sheriff informed the board that the Dispatch desks have been installed and the switch over to the new building for dispatching is scheduled for the beginning of January.

The offices that are currently located in the former Schumaker building are scheduled to move to the Courthouse on November 10. Comstock Construction is going through the building and developing a punch list of required completions that must be done by this date.

VETERANS SERVICE OFFICER:

Dave Daberkow, VSO met with the board to give a quarterly update. Daberkow also presented various expenditure reports of VA benefits throughout the country and the state.

SURPLUS:

Kilker moved, Luttrell seconded to declare surplus the generator previously used at the Courthouse and to advertise it for sale by sealed bids with a minimum bid of \$4,000. All members voted aye.

EXECUTIVE SESSION:

Kilker moved, Bender seconded to enter into executive session at 11:45 am to discuss personnel matters pursuant to SDCL 1-25-2. All members voted aye. The chairman called the board out of executive session at 12:04 pm. No action was taken.

EMT IN TRAINING: Bailee Yule and Charles Thames have started on the Ambulance Crew as EMTs in training at a rate of \$20.53/hour.
